His responsibilities included the strategic development, use, and support of information management and technology function; management of the sector's IT budget for its U.S. product lines; and functional oversight of the sector's operations in the United Kingdom, Sweden, and South Africa. He was instrumental in leading various information technology infrastructure and business transformation programs across the operating group globally.
